Instructions

Designation to be printed on ballot paper

If you have not been endorsed by a registered political party, you may apply to have the word **Independent** appear against your name on the ballot paper. If you do not tick **Yes** in section 1 overleaf your name will not have anything written against it on the ballot paper.

If you have been endorsed by a registered political party, this form will need to be lodged with a declaration of support from the party secretary. Please write the name of the party in the space provided overleaf.

Claim for grouping of candidates

If you wish to be grouped with one or more candidates listed on this form please ensure you tick **Yes** in this section. All candidates in the group must be listed on this form. The order that you submit on the form overleaf will be the order in which group members appear on the ballot paper.

Authorisation to submit a voting ticket

If you are making a claim for grouping, or are an individual candidate who wishes to have someone else lodge a voting ticket on your behalf, you need to complete this section of the form.

If you are an individual candidate who will be lodging your own voting ticket you do not need to complete this section. However, this means that no-one else can lodge a voting ticket on your behalf.

Notes

Claim for Grouping

This group claim may be withdrawn before the hour of nomination by completing form RO21 *Withdrawal of Claim for Grouping of Candidates*.

A candidate in a group must not withdraw his or her nomination without the consent of the other(s) in the group.

This group claim is not valid if:

- (a) the name of any candidate included in the claim is included in any other claim under section 80(1) of the *Electoral Act 1907*.
- (b) the nomination of any candidate whose name is included in the claim is withdrawn before the hour of nomination.

Voting Ticket Claim

The form RO22 Voting Ticket Preferences will be emailed to all candidates or agents on the evening of the close of nominations. If you don't receive a copy then email votingtickets@waec.wa.gov.au to arrange a replacement copy.

Voting tickets must be completed and submitted within 24 hours of the close of nominations, not including weekends and public holidays.
