



# Annual return for continued registration

*Electoral Act 1907, section 62KA*

This form is used to support a Party's eligibility for continued registration. It is to be lodged between 1 June and 30 June each year and must be completed by the Party Secretary for the Party to remain registered.

To remain eligible for continued registration a Party must have at least 500 members who are electors, and a constitution that specifies as an object or activity the promotion of the election to the Parliament of the State of a candidate or candidates endorsed by the party.
