Enrolment information is protected by the *Electoral Act 1907* (s62AF) which provides significant penalties for its misuse, unauthorised disclosure or commercial use.

Persons who have nominated as a candidate for a State Electoral District or Whole of State Electorate can obtain an electorate list for that electorate free of charge.

The electorate list will be provided in two formats:

- 1. A PDF copy of the roll information, sorted alphabetically by surname
- 2. An Excel list including residential and postal addresses.

Registered Parliamentary Parties can only receive electorate lists for electorates in which they have candidates. Applications from Registered Parliamentary Parties are to be signed by the Party Agent.

The Candidate/ Party Agent assumes corporate responsibility for the agreement and ensures with the confidentiality agreement in this application is observed.
