## NOTES RELATING TO ELECTION OF WARDEN, DEPUTY WARDEN AND

### MEMBERS OF CONVOCATION COUNCIL

#### **QUALIFICATION FOR MEMBERSHIP OF CONVOCATION (SECTION 17(1) OF THE *UNIVERSITY OF WESTERN AUSTRALIA ACT 1911*):**

Select one of the following criteria:

- (a) members and past members of the Senate;
- (b) graduates of the University;
- (c) persons not referred to in paragraph (a) or (b) who were members of Convocation immediately before the coming into operation of the *Universities Legislation Amendment Act 2016* section 152;
- (d) persons who the Senate may, from time to time, admit to be members of Convocation.

#### **CANDIDATE BIOGRAPHIES:**

Candidates may supply a biography to support their candidacy. The biography should be submitted headed by the candidate's Surname and First name only (as stated by the candidate on the nomination form). Honorifics etc. can be included in the text the candidate submits.

As provided for in Clause 64 of Statute No.9:

64.(1) A member of Convocation seeking election may submit before the close of nominations a short biography not exceeding 250 words which may include the following particulars:

- (a) degree or degrees, dates of graduation, and other professional qualifications;
  - (b) profession or position;
  - (c) details of work on bodies connected to or associated with the University;
  - (d) prizes won, publications issued and research done;
  - (e) service, whether in war or peace, to the community or any section of it and positions held in connection therewith;
  - (f) such other particulars as the candidate shall deem fit.
- (2) If an election is required, the biography of each candidate for election shall be submitted to the Vice-Chancellor who may delete any matter therein which is deemed to be offensive or untrue.
- (3) Before exercising the power to delete any matter from a biography, the Vice-Chancellor shall if possible consult the candidate concerned.

#### **PLEASE NOTE THAT:**

A recent photograph (head and shoulders) may be supplied with the biography.

The candidate may include in the biography an email address and/or contact phone number to enable voters to contact them to discuss their candidacy.

Copies of all approved biographies will be forwarded to voters with the voting papers if an election is required. Biographical material will be presented below the candidate's Surname and First name and, consistent with Clause 66 of Statute No. 9, particulars (if available) of year of admission to Convocation, qualification for membership, whether the candidate is a current office holder seeking re-election and the names of the Proposer and Seconder (not part of 250 word biography).
