## Introduction

This summary report has been prepared for submission to the Minister, and subsequently each House of Parliament, in accordance with section 175ZG of the *Electoral Act 1907* (the Act) to summarise the operation of Part VI of the Act during the 2018–2019 financial year.

All fifteen registered political parties complied with the legislative requirement of the Act to lodge an annual return for 2018–2019. In addition, five unregistered political parties complied with annual disclosure requirements, as well as five associated entities. Copies of all annual returns were available publicly on the Commissions' website from 30 December 2019. Data provided in financial disclosure returns submitted for the 2018–2019 financial year are also detailed online on the Commissions' website, [www.elections.wa.gov.au](http://www.elections.wa.gov.au).

Funding and disclosure requirements resulting from the 2018 Darling Range by-election continued into the first half of the 2018–2019 financial year. Election returns were lodged by 8 October 2018, with all funding claims submitted by the deadline of 12 November 2018 and paid out in the same month. Details of election returns and funding claims from the 2018 Darling Range by-election were reported in the 2017–2018 Political Finance Annual Report, which was tabled in April 2019.

As required by the Act, the Commission has continued to maintain the register of political parties, processing two amendments to the register in 2018–2019. Any amendments to the register must satisfy the requirements of the Act with regard to the grounds that permit an application to be approved, as well as advertising the application and inviting objections to the application. Both applications to amend the register were approved in accordance with the Act, with both being applications by a political party to change its registered party name and abbreviation.

The Commissions' efforts to build awareness and understanding of the funding and disclosure regime in Western Australia will intensify leading up to the 2021 State General Election. The Commission will undertake a range of education and stakeholder engagement measures over the coming months to ensure parties and candidates are fully aware of their obligations under the Act.

# Summary of disclosures and public funding through the 2018–2019 financial year

## 1. Financial disclosures

### 1.1 Annual returns by political parties and associated entities

- \$15,415,530.75 in gifts and other income was declared by 20 political parties.
- \$2,217,514.00 in gifts and other income was declared by five associated entities.
- One political party lodged a late return but the information was available publicly by the deadline required under the Act

Under section 175N(5) of the Act, political parties and associated entities are entitled to meet their State disclosure obligations by lodging the same return prepared for the Australian Electoral Commission under the *Commonwealth Electoral Act 1918* (CEA)<sup>1</sup>, if they are obliged to submit a Federal return. Three registered political parties (Liberal Party, The Nationals and WA Labor) met their disclosure requirements by submitting their Federal return for the 2018–2019 reporting period.

<sup>1</sup> The CEA disclosure threshold for individual donations for 2018–2019 was \$13,800, whereas the State threshold was \$2,500.

### 1.2 Part VI disclosures

- Two political parties amended their registered party names and abbreviations during the 2018–2019 financial year. The Micro Business Party changed their name to the Small Business Party, and the Fluoride Free WA Party changed their name to the Health Australia Party.
- Four political parties updated details for their party agent.
- Three political parties changed their party secretary.
- 153 public agencies disclosed to Parliament expenditure of \$103,307,839.44 relating to advertising agencies, market research, polling, direct mail and media advertising agencies.
