# Executive Summary



The Political Finance Annual Report 2009 is a compliance review of the disclosures made under the provisions of Part VI of the *Electoral Act 1907* (the Act) in 2008–2009. For 2008–2009, those disclosures include:

- Gifts and/or other income from political parties and associated entities for the financial year.
- Electoral expenditure by political parties for the 2008 State General Election and 2009 Fremantle by-election.
- Gifts, other income and expenditure by candidates in the 2008 State General Election and 2009 Fremantle by-election.
- Electoral reimbursement funding for political parties in the 2008 State General Election and 2009 Fremantle by-election.
- Registration of agents of political parties.
- Disclosure by public agencies in relation to certain expenditure.

Overall, disclosures made to the Electoral Commissioner complied with the requirements under the Act. Areas of concern relate to timeliness and accuracy of the lodgement of returns, record keeping by some candidates and parties and the interpretation of the ambiguity of section 175ZE in relation to the disclosure of certain expenditure.

## Summary of disclosures through 2008–2009 2008–2009 Annual Returns by Political Parties and Associated Entities

- \$13,144,831.71 in gifts and other income was declared by 19 political parties
- \$2,528,904.00 in gifts and other income was declared by 4 associated entities.

## 2008 State General Election

- \$7,674,270.15 in election spending was declared by political parties candidates and Legislative Council groups
- \$444,979.98 in gifts was declared by candidates and Legislative Council groups
- \$3,238,077.64 was paid to 16 independent candidates and political party agents as reimbursement for their electoral expenditure.

## 2009 Fremantle by-election

- \$273,076.05 in election spending was declared by political parties and candidates
- \$16,600.00 in gifts was declared by candidates
- \$27,224.77 was paid to 4 candidates and political party agents as their election funding reimbursements.

## Part VI of the *Electoral Act 1907* disclosures

- 5 registered parties updated their party agent details
- 222 agencies and statutory authorities disclosed to parliament expenditure of \$87,533,315.81 under section 175ZE of the Act.

In auditing compliance with the Act it was found that generally political parties, associated entities, individual candidates, Legislative Council groups and other persons fulfilled their obligations. Improvements can be made in the areas of:

- Record management, in particular keeping up to date gift, acknowledgement and expenditure books.
- Providing for more efficient means by which parties can collate reports in disclosure periods with multiple electoral events.

## Background

This report considers the operation of Part VI of the *Electoral Act 1907* (the Act) over the 2008-2009 financial year. Part VI of the Act requires all political parties, associated entities, individual candidates, Legislative Council groups and other persons to provide the Electoral Commissioner with details of gifts and/or income received and expenditure incurred for electoral purposes. Also, those public agencies that have a requirement to lodge an annual report to parliament under Part V of the *Financial Management Act 2006* are required by section 175ZE of the Act to report all expenditure in relation to advertising agencies, market research organisations, polling organisations, direct mail organisations and media advertising organisations.

This is the thirteenth annual report to Parliament in accordance with section 175ZG of the Act and details the compliance on:

- annual disclosure returns lodged by political parties and associated entities for this period
- election returns submitted for the 2008 State General Election and 2009 Fremantle by-election
- changes in the registration of agents of political parties
- details on certain expenditure provided by public agencies and statutory authorities in this period.

The 2008-2009 political finance disclosure schedule, which highlights key disclosure dates during the reporting period, is included as Appendix 1.

## Definitions used in this report and essential features of electoral funding and disclosure

### Annual Returns

All political parties (whether registered or not) and their associated entities are required to lodge an annual (financial year) return by 30 November, disclosing all gifts and other income received for the previous financial year.

### Election-related Returns

After an election or by-election, all participating parties, candidates, Legislative Council groups and other persons are required to send an election return to the Electoral Commissioner within 15 weeks after polling day.

Political parties are required to disclose only electoral expenditure incurred for an election, as they disclose all gifts and other income in their annual returns. Associated entities are not required to disclose electoral expenditure incurred for an election.

Candidates are required to disclose all gifts received and electoral expenditure incurred during the disclosure period for the election, which ends 30 days after the current election and:

- if the candidate was a candidate in a previous election (in the last five years), it commences 31 days after polling day in the previous election in which they were a candidate
- for new and other candidates, it commences one year before the day of nomination in the present election.

Legislative Council groups must submit a return disclosing all gifts received and expenditure incurred between the hour of nomination and 30 days after the current election.

People other than political parties, associated entities, candidates and groups who incur expenditure for political purposes must disclose all gifts received from 31 days after polling day in the last preceding general election until 30 days after polling day for the current election. Relevant details of gifts that are expended partially or wholly for political purposes must be provided if the gifts equal or exceeds the specified amount. The specified amount for the 2008 State General Election was \$1,800 and for the 2009 Fremantle by-election was \$2,100. Other people who incur electoral expenditure in relation to an election exceeding \$500 must also lodge a return disclosing relevant amounts of expenditure. Other people may include interest groups, lobby groups, welfare groups, unions and associations.

## Electoral Funding

Candidates or their agents at a State election or by-election can apply to be reimbursed for electoral expenditure incurred, subject to receiving more than 4% of the total formal votes in their electorate. The agent of a registered political party may receive payment if the endorsed candidates for a registered political party collectively receive more than 4% of the total formal votes in the State. An agent of a political party is required to submit one consolidated claim for electoral funding. Candidates included in a Legislative Council group can receive payment if the group as a whole polls over 4%.

For each eligible candidate the election funding reimbursement amount, calculated annually under section 175LC(2) of the Act, is to be paid to that candidate's agent for each valid first preference vote received in an election. The amount for the 2008-2009 annual report period was \$1,56888, this being the amount applied to claims for the 2008 State General Election and 2009 Fremantle by-election.

If actual eligible electoral expenditure incurred by that candidate or group is less than the amount that would be paid using the above calculation, then this lesser amount is the amount to be reimbursed.

Eligible electoral expenditure is defined at section 175 of the Act.

Payment is made to the political party for endorsed candidates. Payments to unendorsed candidates are made to their agent or to the candidate directly if no agent is appointed. For Legislative Council groups not endorsed by a registered political party, payment is made to the agent of the group or if no agent has been appointed the candidate whose name appears first in the group.

## Gifts

Gifts equal to or above the specified amount must include the name and address of the person who made the gift. In accordance with Part 2 of the *Electoral (Political Finance) Regulations 1996*, the specified amount of \$1,800 was reviewed after the 2008 State General Election. The revised figure of \$2,100 was published in the Government Gazette on 3 October 2008 and applied to the 2009 Fremantle by-election. Acceptance of donations from unidentified persons or sources equal to or more than the specified amount is prohibited under the Act. Under section 175R(5) of the Act, anonymous donations above the specified amount are payable to, or may be recoverable by, the State.

## Public Agencies

The definition of a Public Agency under Part VI of the Act is broad and encompasses not only departments of the Public Service or organisations specified in Schedule two of the *Public Sector Management Act 1994*, but also a number of other organisations. This definition also includes a body or office that is established for a public purpose under a written law, as well as a body or office that is established by the Governor or a Minister. Any corporation or association over which control can be exercised by the State, Minister or above bodies is also defined as a public agency.

## Records to be kept

Under the *Electoral (Political Finance) Regulations 1996*, agents of political parties, candidates and groups must maintain:

- a receipt book, for recording details of money received
- an acknowledgement book, for recording details of gifts other than money received
- bank and financial institution statements
- an expenditure book.

The agent of an associated entity must keep all of the above except for an expenditure book.

Other people who incur expenditure for political purposes must keep a record of all gifts received for political purposes and maintain:

- a receipt book
- an acknowledgement book
- bank and financial institution statements.

Other people who incur electoral expenditure must also maintain:

- an expenditure book
- bank and financial institution statements.

All records, bank and financial institution statements must be retained for six years.

In accordance with regulation 11 of the *Electoral (Political Finance) Regulations 1996* the Electoral Commissioner has issued the *Electoral (Political Finance) Notice 2000*. The *Electoral (Political Finance) Notice 2000* approved the use of computerised accounting systems to keep the following records:

- a receipt book
- an acknowledgement book
- bank and financial institution statements.

A political party may apply to the Electoral Commissioner for approval for the party to keep or cause to be kept a system of accounting records other than those prescribed in the legislation or regulation.

## Role of the Western Australian Electoral Commissioner

The Electoral Commissioner is responsible for maintaining a register of political party agents and obtaining the relevant information from parties, associated entities, candidates, groups and other persons through annual and election-related disclosure returns. The Electoral Commissioner is empowered to check all returns, obtain any information relevant to disclosure requirements, interview people and scrutinise bank or other financial accounts where donations may be deposited. The Electoral Commissioner also prepares an annual report (this report) on the operation of Part VI of the Act in relation to the previous financial year. This is submitted to the Minister for Electoral Affairs, who tables the report in Parliament.

## Access to Returns

The Western Australian Electoral Commission (WAEC) retains copies of each political finance return. In accordance with section 175ZC of the Act, members of the public may view or obtain copies of returns, which are available four weeks after the end of the lodgement period. The 2008 State General Election returns were made available to the public on 19 January 2009. 2009 Fremantle by-election returns were made available to the public on 29 September 2009. Annual returns for the 2008–2009 financial year were made available on 29 December 2009. Annual returns of political parties and associated entities lodging a Commonwealth return with the WAEC can be viewed on the Australian Electoral Commission's website at [www.aec.gov.au](http://www.aec.gov.au).

## Publications

The WAEC produces guidelines which are regularly updated and outline the provisions of political finance legislation in Western Australia and the implications for people involved in the electoral process. Copies of the guidelines and relevant forms are available from the WAEC on request, or can be downloaded from the Commission's website at [www.waec.wa.gov.au](http://www.waec.wa.gov.au).

# 2008-2009 Annual returns of political parties and associated entities



- Political parties declared \$13,144,831.71 in income
- Associated entities declared \$2,528,904.00 in income
- 96.5% of all income was declared under the Federal disclosure scheme and lodged with the WAEC

## Background

The Act provides for the Electoral Commissioner to authorise officers to investigate returns required under Part VI of the Act. In order to reduce the administrative burden on political parties and associated entities who lodge their annual disclosure return with the Australian Electoral Commission (AEC) a collaborative approach has been taken to audit processes. The AEC conducts a review of annual returns to check their compliance with the disclosure provisions of the *Commonwealth Electoral Act 1918* similar to audits that the WAEC undertakes under the Act. The AEC audit focus is on the returns lodged in the financial year of a Federal election. There is an ongoing collaboration between the WAEC and AEC to ensure that there is limited duplication of investigative functions.

This reporting and audit period continued to demonstrate the discrepancy between State and Commonwealth specified amounts. Effectively this means that the political parties that lodge annual returns made under the *Commonwealth Electoral Act 1918* are able to disclose gifts and other income under a significantly higher disclosure threshold than those lodging State returns. For the 2008–2009 financial year the specified amount for annual returns lodged under the *Commonwealth Electoral Act 1918* was \$10,900 as compared to \$1,800 for annual returns lodged under the Act. At the date of this report there is no indication that there will be any change to this situation.



## Summary of activity

Agents of the various political parties who had submitted annual returns previously were sent letters in July 2009 reminding that the disclosure period for the 2008–2009 annual returns ended on 30 June 2009 and that returns were due to be lodged with the WAEC by 30 November 2009. A total of nineteen political parties and four associated entities lodged disclosure returns for the 2008–2009 period. The Act provides for political parties and associated entities to submit returns prepared under the *Commonwealth Electoral Act 1918* to reduce their administrative burden. Of note, 96.5% of the total gifts and other income declared by political parties as well as gifts and other income declared by associated entities was declared to the WAEC under this provision.

All political parties submitted their annual returns by 29 December 2009 when the returns were made publicly available. This is a substantial improvement from previous lodgement periods.

The total amount of gifts and other income declared by political parties was \$13,144,831.71 and \$2,528,904.00 by associated entities.

## Result of investigation into annual returns

The WAEC employed an independent auditing firm, Stantons International, to audit annual returns of a political party not audited by the AEC. In consideration of the heavy audit schedule for 2008–2009 in terms of electoral activity and the substantial amount of disclosure undertaken outside of the Act's investigative powers, only one political party's annual return was audited. Three political parties that lodged 'nil' returns were required to substantiate these returns through financial records submitted to the Electoral Commission's Electoral Liaison Officer.

Stantons International randomly sampled the records of one political party to test compliance with the disclosure requirements of the Act. A high level of compliance was demonstrated by the political party during the review. The review of the 'nil' returns by political parties resulted in two parties declaring that they were no longer active and the third party being required to update their disclosure for the financial year.

Data provided in the annual returns by political parties and associated entities are included as Appendices 2 to 6 of this report.

## Background

Political party agents, Legislative Council group agents and candidate agents for the 2008 State General Election received copies of the relevant funding and disclosure forms, together with explanatory letters in October 2008 reminding of their obligations to disclose gifts received (candidates and groups only) and expenditure incurred for the State General Election. Candidates, Legislative Council groups and political parties were also advised whether they were eligible to claim the reimbursement of electoral expenditure and given information regarding the reimbursement process. Candidates who did not appoint agents, or who were not endorsed by the registered parties, received their letter and the relevant forms personally. Of the 472 candidates at the State General Election 376 (79.66%) had appointed agents by the 6.00pm deadline on 5 September 2008.

## Summary of activity

The disclosure period for political parties, candidates, Legislative Council groups and other persons ended 30 days after polling day, which was 6 October 2008. The 2008 State General Election returns were due within 15 weeks of polling day which was 22 December 2008. No election-related returns were received from other persons and the following table outlines the number of outstanding returns as at the last day for lodgement of election-based returns. The outstanding returns were obtained after substantial effort and threat of legal action. The final election related disclosure was obtained 10 months after the 22 December 2008 deadline.

Claims for the reimbursement of electoral expenditure in relation to the 2008 State General Election were due within 20 weeks of polling day. All eligible claims were processed by 30 January 2009. The total amount of electoral expenditure reimbursed to eligible candidates and party agents was \$3,238,077.64. There were ten candidates who were not endorsed by a political party and six parties who received electoral funding.

## Result of investigation into the 2008 State General Election

The WAEC employed an independent auditing firm, Stantons International, to audit all of the election returns lodged by political parties, Legislative Council groups and candidates in relation to the State General Election. A review by Stantons International randomly sampled the records of six political party expenditure returns, eight Legislative Council group gifts and expenditure returns and 119 candidate gifts and expenditure returns to test compliance with the Act. Thirteen 'nil' returns were reviewed by the Electoral Commission's Electoral Liaison Officer.

The results of the investigation are consistent with those of the 2005 State General Election. There were no instances of deliberate misrepresentation, however there were several instances of errors of omission or issues that required clarification from the various parties and the voluntary return of an overpayment of public funding. The incorrect classification and supporting documentation of electoral expenditure remains a concern during the disclosure process and clearer guidance will be produced for the benefit of parties and candidates. The returns that required clarification and changes have been updated with the Electoral Commission.

Data provided in the 2008 State General Election returns are included as Appendices 10 to 16.

# 2009 Fremantle by-election returns and funding claims



- 11 candidates reported a total income of \$16,600.00 and a total expenditure of \$48,334.85
- 5 parties declared \$178,199.35 in electoral expenditure
- 3 candidates were reimbursed a total of \$27,224.77 in relation to their electoral expenditure

## Background

Political party agents and candidate agents for the Fremantle by-election received copies of the relevant reimbursement of electoral expenditure and disclosure forms, together with explanatory letters in June 2009 reminding of their obligation to disclose gifts received (candidates only) and expenditure incurred for the Fremantle by-election. Candidates and political parties were also advised whether they were eligible to claim for reimbursement of electoral expenditure and given instructions regarding the claim process. Candidates who did not appoint agents or were not endorsed by a political party, received their letter and the relevant forms personally. Of the eleven candidates at the by-election, six had appointed agents by the 6.00pm deadline on 15 May 2009.

## Summary of activity

The disclosure period for political parties, candidates and other persons ended 30 days after polling day which was 15 June 2009. No election-related returns were received from other persons and all political party and candidate returns were lodged on time. The following table summarises the various disclosures made in the by-election.

Claims for the reimbursement of electoral expenditure in relation to the Fremantle by-election were due within 20 weeks of polling day. All eligible claims were processed by the deadline of 5 October 2009. Of the 11 candidates at the by-election, 3 candidates received over 4% of first preference formal votes. The total amount of electoral expenditure reimbursed to candidates and political parties was \$27,224.77.

## Result of investigation into the 2009 Fremantle by-election

The WAEC employed an independent auditing firm, Stantons International, to audit the election returns lodged by political parties and candidates in relation to the 2009 Fremantle by-election. A review by Stantons International randomly sampled the records of two political party expenditure returns and three candidate gifts and expenditure returns.

The results of the investigation indicate that parties and candidates are taking more care with recordkeeping and these results are an improvement to previous investigations. The most significant area of improvement was in the use of a receipt book, expenditure book and an acknowledgement book as required by the *Electoral (Political Finance) Regulations 1996*.

Data provided in the 2009 Fremantle by-election returns are included as Appendices 7 to 9 of this report.

# Registration of agents of political parties



» 5 new agents were registered as agents of political parties

## Background

All political parties are required to appoint an agent who must register with the Electoral Commissioner. The appointment takes effect on the entry of the name and address of the party agent in the party agents register at the WAEC and ceases to have effect when the name and address is removed. An agent assumes responsibility for lodging disclosure returns and claims for the reimbursement of electoral expenditure.

To be eligible for appointment as an agent of a political party, the nominated person must:

- be over the age of 18 years
- be appointed in writing by the party
- declare their eligibility and consent to the position
- not have been convicted of an offence under the disclosure provision of the Act.

When there is no agent of the political party, all members of the party's executive committee jointly assume responsibility for the disclosure obligations in Part VI of the Act.

## Summary of activity

There were five notices of appointment of an agent by a political party lodged during the 2008–2009 reporting period.

# Section 175ZE of the Act – Reporting by Public Agencies



➤ Total expenditure over the 222 agencies that submitted an annual report to Parliament was \$87,533,315.81

## Background

Public agencies who are required to publish an annual report under Part V of the *Financial Management Act 2006* or any other written law must include a statement in that annual report of all expenditure incurred on behalf of the public agency during the reporting period in relation to:

- advertising agencies
- market research organisations
- polling organisations
- direct mail organisations
- media advertising organisations.

This statement must detail the total amount of the expenditure, the amount of expenditure for each heading listed above and the name of each person, agency or organisation to which an amount was paid. No details required if the amount of expenditure under a heading is less than the specified amount of \$1,800, although a 'nil' statement is still required to be published.

While the exact purpose of this section of the Act and its operation is not clear, it may be that it merely provides a consolidated annual view of public agency advertising related expenditure for comparative purposes. Efforts to assist agencies in complying with the reporting requirements under section 175ZE of the Act are hampered by a lack of clarity of the disclosure categories against which expenditure must be declared.

An example of this lack of clarity is the issue of declaring expenditure under polling organisations. There is a contrast between a polling organisation that is commissioned to undertake registering the votes of electors at an election and an organisation that is commissioned to undertake analysis of public opinion on a subject. It can be argued that the second definition of polling organisations can be very similar to the category of market research organisations, which can be categorised as the systematic collection and evaluation of data regarding customer's preferences for actual and potential products and services.

Similarly there seems to be little difference between the two categories of advertising agencies and media advertising agencies. Advertising can be defined as a form of communication whose purpose is to attempt to persuade potential customers to purchase or to consume more of a particular brand of product or service. Media is defined as the materials and techniques used to produce a work or the storage and transmission tools used to store and deliver information or data. The difference between an organisation that performs the first function and not the second may cause a lack of clarity when reporting expenditure.

## Summary of activity

There is considerable difficulty in compiling a definitive list of public agencies that are required to declare this expenditure under Part VI of the Act. Of the 222 public agencies that submitted an annual report to Parliament, 52.25% were found to have reported the expenditure in accordance with section 175ZE of the Act. 52 agencies failed to declare any expenditure as required by the Act in their annual report. Total expenditure from the 170 agencies that declared expenditure was \$87,533,315.81.

Appendix 17 lists the specific details of the various public agencies disclosure which is summarised in Table 4.

Of the public agencies that reported expenditure under the Act, 31.76% did not comply with the level of disclosure required. Public agencies need to ensure that they provide the total amount of all expenditure spent, a total of all expenditure spent in the five classes of expenditure and the name of each person, agency or organisation to whom an amount was paid in their annual report.

Efforts to assist agencies in complying with the reporting requirements under section 175ZE of the Act are hampered by a lack of clarity of the disclosure categories against which expenditure must be declared. This will be addressed by the WAEC prior to the next Political Finance Annual Report.

# Concluding observations



The general level of compliance has improved from previous years with all disclosures for the 2008-2009 annual returns and 2009 Fremantle by-election lodged before disclosure returns were made available to the public. The main issue identified during the audit processes was the inaccurate categorisation of electoral expenditure for election-based returns which, while having a negligible impact on the total expenditure disclosed, required clarification to assist parties and candidates in meeting their reporting obligations.

Investigation into the disclosure returns for 2008-2009 has demonstrated the importance of communication in increasing the levels of compliance. To assist in communication with parties and candidates guidelines covering political finance legislation in Western Australia were revised for, and after, the 2008 State General Election.
