




SUMMARY OF EXPENDITURE INCURRED IN RELATION TO THE ELECTION

Expenditure within the following categories should be disclosed if the advertising itself was conducted during the election period, regardless of whether or not the expense or production of material was incurred during the election period. Note that this will not include all types of expenditure, only those defined at section 175 of the *Electoral Act 1907*. For example, nomination fees are not considered electoral expenditure under section 175.
